Trustees' Report

The trustees present their report and financial statements for the year ended 28 February 2023.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Charity's Memorandum & Articles of Association, the Companies Act 2006 and the Statement of Recommended Practice for charities applying FRS 102.

Structure, governance and management

Rite to Freedom Ltd is a company limited by guarantee governed by its Memorandum and Articles of Association and was incorporated on 2 February 2010. It became registered as a charity with the Charity Commission on 11 April 2011. The liability of the Members is limited. In the event of the Company being wound up every Member of the Company undertakes to contribute such amount as may be required (not exceeding £10) to the Company's assets.

The Board of Trustees

The trustees, who are also the directors for the purposes of company law, and served during the year, were:

Appointment of Trustees

Trustees can be appointed at any general meeting, provided the conditions outlined in the charity's governing document are met.

Trustee induction and training

New trustees are given a copy of the Memorandum and Articles of Association, and the latest accounts and are explained their role by a current member of the board. Continuing trustees are advised of updates as they arise.

Organisational structure

The charity is governed by the board of trustees, with operations and projects led by the creative director and project & development co-ordinator.

Public Benefit

The trustees, in their meetings, have referred to the Charity Commission's guidance on Public Benefit in making their decisions. Rite to Freedom Ltd exists in order to positively impact on the lives of under-privileged and socially excluded people through offering nature connection, personal development and creativity courses. Programmes are offered free of charge to participants, and priority is always given to socially excluded groups. In 2022 to 2023, approximately 35 people directly benefited from the core programmes, with 21 new participants and over 100 other people joining other events. This creates far ranging knock-on effects due to an increase in mental wellbeing and decrease in addictive behaviours. This year we have completed a research evaluation project looking at the ripple effect of our work on the lives of those connected to our community – including family, friends, colleagues.

Risk management

The Trustees assess the risk to which Rite to Freedom Ltd is exposed on a continuous basis. This includes the on-going monitoring of core reserves (see the reserves policy below).

Aims and activities

Our vision is of a society where people's actions (for example crime, substance abuse) are understood as being an expression of dysfunctional families, communities and societies when healthy means of expression have not been modelled or available. Rite to Freedom Ltd believes that all human beings should have equal access to supportive

communities; to learning healthy ways of expressing and untangling confusing pasts and behaviours; to accessing natural environments; and to exciting, creative and inspirational experiences.

Our aims:

- To promote values of respect, equality, authenticity and trust, and create spaces where healthy communication and sharing can occur.
- To increase access to, and deepen people's connection with, natural environments
- To promote meaningful self-expression through the creative process, including but not exclusive to: the written and spoken word, film, photography, music, arts and crafts
- To provide positive, authentic role models
- To offer contemporary 'rites of passage'
- To demonstrate the use of story and narrative as a means of transformation
- To support and guide the increase of participants' self-awareness, self-belief and self-compassion
- To build stronger communities through inter-generational sharing and mentoring
- To shift attitudes away from 'labels' and towards 'stories'
- To prioritise engaging with people who are socially excluded, marginalised and would otherwise be unlikely to access similar interventions.

Our activities

Rite to Freedom Ltd (R2F) offers life changing residential courses and other events for adults in addiction recovery. This is recovery in the widest sense and in mixed gender groups.

Our events combine creativity, nature connection, mindfulness, storytelling and creativity, one to one support, supervision and meditation. On our flagship Dartmoor, New Tribes Residentials each participant is invited into a space of 'timelessness', with no connection to technology, and without knowing what is happening next. This allows a level of fluidity, a building of trust, and 'letting go' of the usual constraints of daily life. A sense of seamlessness occurs as each activity is choreographed to carefully build upon the last, weaving in myth, mystery with the wild landscapes acting as a mirror to internal process and healing. Key to the building of trust is all of the staff and volunteers have direct life experience of addiction. Engaged, experienced and appropriate participants are invited back as volunteer staff on the New Tribe Residentials, providing work experience and a profound continuation of their personal development and healing. Our Creative Pathways programme supports this work to go deeper for those who are in longer term recovery, and serves as a follow-on programme for those who have already been through our New Tribes Residential.

Initiated in the COVID-19 pandemic, we continue to supplement our residential programmes with a series of online retreats and wider events. Our programme is now mostly in person retreats and events plus other regular online meetings.

Achievements and performance

In the past year we have continued to offer our range of connected and creative support to the recovery community in Devon and beyond. We continue to work with those in established recovery for our main programmes, asking for an abstinence of a minimum of six months from addictive behaviour or chemical. We find from 6 months participants are more receptive to the work we offer; after what is often the chaos of early recovery. We welcomed 16 new participants to our community through our Devon residential programmes, many of these engaging further with other programmes and events.

In 2022 we ran two New Tribes Residentials at Heathercombe on Dartmoor in July and September, both running at full capacity with waiting lists. We also ran one New Tribes Residential in Ireland in October. We extended our staff training programme with two full training weekends which served to build confidence and deepen the healing work for participants who had previously been through our residential programme.

We ran our first Creative Pathways to Healing and Meaning residential programme in 2022 with our second one planned for May 2023. Our Recovery Conversations include an impressive array of speakers and are being prepared as

a programme of podcasts accessible through a membership scheme. Our Home Turf Days, where members of our community have the opportunity to step up and share their local area with a group of others, continue. Our Multi-Addictions Meetings run online every two weeks and are open to the whole recovery community and attract both regular participants and as an entry point into the work that we offer for people who haven't joined an event before.

New Pathways standalone days, residentials and ongoing support

A new programme consolidating our ongoing work with partner organisations. This is an adaptive, bespoke programme for those with 1 month abstinence or more. Delivered by senior, lived experience R2F facilitators and trainee facilitators.

In the summer of 2022 we launched our online shop selling a range of merchandise based on the Creative Pathways archetype illustrations – printing onto cards, t-shirts and posters. In November we published our first book, Creative Pathways – a journey through four archetypes, which has had an incredible reception. This is a beautiful introduction to the Lover Creator, the Warrior Protector, the Magician Healer and the Sovereign Overseer archetypes as an internal compass for navigating our own personal journeys. It includes inspirational poetry by Caspar Walsh, and stunning original images conceived and designed by Caspar Walsh and brought vividly to life by Philip Harris.

Since March 2022 we have run a regular Multi-Addictions Recovery Meeting every two weeks. This is designed to support the whole of the addiction recovery community, including all chemical and behavioural addictions. Members of the community hold the meetings and we invite guest speakers to share on specific recovery/life/seasonal related themes. The rotation of these positions gives our volunteers opportunities to become more involved, build confidence and enhance their skills.

We have continued developing and running our series of Recovery Conversations - regular public online talks and discussions with experts in nature connection, mindfulness and creativity. These talks have been open to anybody interested in our work, serving as a way to increase the awareness of our offerings and providing an introductory experience for people considering signing up to a retreat or event. These Recovery Conversations have also reached the demographic of people who have not yet met our clean time criteria. In October 2022 we decided to turn this offering into a podcast series rather than open public events to allow us to reach a wider audience that is less event and time specific. We are currently building our library of podcasts which will allow people to have access to the recordings in their own time. We have continued to attract an extremely high calibre of speakers with recent podcast recordings featuring renowned mythologist Michael Meade, Dartmoor poet Tom Hirons, photographer Chris Chapman, and Bristol based performer Malaika Kegode.

In the last year we have run two weekend staff facilitation training events and several stand-alone days. We've developed a large pool of people who have been through our New Tribes programme over recent years with a lot of energy to stay involved who want to deepen their own journey of recovery and support our ongoing work with new participants. It has been important to us to continue to offer training opportunities to our volunteer staff team, providing opportunities for those who wish to step further into a position of leadership. This expands our team of experienced facilitators with lived experience of recovery committed to deepening their own journeys. In 2022, 16 of our community members joined our staff training events.

Our Family and Friends Programme is a new addition to our programme, responding to a clear need in the wider community amongst those that support their loved ones in active addiction and in recovery. We have become increasingly aware of a significant lack of provision in this area. This includes many members of our current community and is a development that has been very much supported by our newest trustee, Virginia Compton, herself having supported a partner in recovery over many years. We are developing this slowly with a series of in person days and online calls offered since September 2022.

Our regular 'Home Turf Days' offer ongoing opportunities for connection to those who have been through our residential programmes. Members of our community are invited to welcome others to a beautiful spot local to them to deepen into nature connection and share our ongoing journeys with each other.

Our Community Council continues to support the charity's vision, ethos, aims and objectives. This is made up of individuals in recovery who have been involved with R2F for 2 years or more. The Community Council aims to include an open dialogue and 'bridge' with the board of trustees to support decision making and any new project development. The development of the Community Council is in ongoing discussion with all parties.

Financial review

The charity is primarily funded by grants and donations. The total income for the year was £75,111 (2022 - £78,011). Of this amount, £62,282 was from grants (2022 - £75,546), and £5,199 (2022 - £1,965) was from donations. There was also £7,630 of other income received during the year from projects, course fees and sale of merchandise (2022 - £500).

The majority of the grant funding has come from the National Lottery, this year totalling £36,167 (2022 - £65,546). A grant was also received from Devon Community Foundation amounting to £21,115 (2022 - £0) and an additional grant of £5,000 has been received from an anonymous funder (2022 - £10,000) specifically to run residential programmes in Ireland.

Total expenditure for the year was £94,089 (2022 - £66,795) as the charity continues to deliver its core activities. Overall reserves amounted to £37,409 (2022 - £56,387) at the yearend as the charity continues to deliver on its objectives.

The National Lottery Community Fund grant will ensure that the charity can continue its activities with secure funding in place for one more year.

Reserves Policy

The board of trustees continually reviews the reserves of the charity. Assets must be sufficient to enable the charity to operate effectively. The charity used a number of restricted funds during the year; the purpose of these funds is detailed in the notes to the financial statements.

The charity aims to hold £15,000 in unrestricted reserves at all times. At the yearend unrestricted reserves had increased to £14,676 (2022 - £4,453). The trustees are looking to maintain these reserve levels in order to ensure that the charity is able to meet all of its legal obligations should funding be withdrawn.

Plans for Future Periods

With our current National Lottery Reaching Communities Grant coming to an end this year, we are entering a new round of funding applications to continue our current programmes and to adapt and extend them where they are most needed and wanted. This includes developing our Family and Friends programme and spreading our work outside of Devon. The National Lottery grant has provided us with a stable base of support over the last 3 years that has allowed us to consolidate and strengthen the work that we offer the world.

We are developing an extension of our Devon based programmes in Cornwall and Bristol and seeding new communities in these areas. We have started work on the ground through members of our community who live in these areas who bring their passion for recovery work and reaching out to their local communities.

We are developing a membership platform through our website as another way of diversifying our income streams. Selective creative content will be available for members who pay a monthly subscription, including full access to the wide range of Recovery Conversations that Caspar has been hosting. We will also have regular special offers on our merchandise and access to themed conversations from our Multi Addictions Meetings, amongst other content.

We will be extending and growing our range of merchandise and distribution to directly support the work of the charity and to be part of diversifying and stabilising our income streams.

Future creative projects

We are developing long-term projects to amplify and celebrate the voices of recovery throughout Devon and the southwest. This will include working with other organisations supporting recovery in the widest sense, including physical, mental and spiritual health. This will focus on a mixture of new delivery initiatives including:

- Celebrating the work co-created over the last five years at a number of venues including a Cornwall launch event at The Poly in Falmouth in September 2022. To include film screenings, Q&A and a week-long exhibition.
- Continuing partnership development with Exeter Phoenix to build on our sell out multimedia show at the Phoenix in 2022.
- A community wide photographic project highlighting and celebrating the recovery journeys of community members. To be exhibited across the southwest through live events, publication and online.
- Continue our partnership and research work with Exeter University's Psychopharmacology department.
- Through a range of creative projects, increase diversity and inclusion throughout all delivery and employment within the charity.

1 Accounting Policies

Charity information

Rite to Freedom Ltd is a private company limited by guarantee incorporated in England and Wales. The registered office is Wessex House, Teign Road, Newton Abbot, Devon TQ12 4AA

1.1 Accounting convention

These accounts have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102"), "Accounting and Reporting by Charities" the Statement of Recommended Practice for charities applying FRS 102, the Companies Act 2006 and UK Generally Accepted Accounting Practice as it applies from 1 January 2019. The charity is a Public Benefit Entity as defined by FRS 102. The disclosure requirements of section 1A of FRS 102 have been applied other than where additional disclosure is required to show a true and fair view.

The accounts are prepared in sterling which is the functional currency of the charity.

The accounts have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

At the time of approving the accounts, the trustees have a reasonable expectation that the charity has adequate future funding planned in order to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the account.

1.3 Incoming resources

Items of income are recognised and included in the accounts when all of the following criteria are met:

The charity has entitlement to the funds;

any performance conditions attached to the item(s) of income have been met or are fully within the control of the charity;

there is sufficient certainty that receipt of the income is considered probable; and the amount can be measured reliably

No amounts are included in the financial statements for services donated by volunteers.

1.4 Resources expended

Liabilities are recognised as resources expended as soon as there is a legal or constructive obligation committing the charity to the expenditure. All expenditure is accounted on the accruals basis.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the independent examiner's fees and costs linked to the strategic management of the charity.

All costs are allocated between the expenditure categories of the SOFA on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly; others are apportioned on an appropriate basis e.g. staff time or estimated usage.

1.5 Irrecoverable VAT

Irrecoverable VAT is included in the Statement of Financial Activities, and is reported as part of the expenditure to which it relates.

1.6 Tangible Fixed Assets and Depreciation

Tangible fixed assets, other than freehold land, are stated at cost or valuation less depreciation and any provision for impairment. Depreciation is provided at rates calculated to write off the cost or valuation of fixed assets, less their estimated residual value, over their expected useful lives on the following basis:

1.7 Fund accounting

Funds held by the charitable company are either:

Unrestricted general funds – these funds can be used in furtherance of the charitable objectives at the discretion of the trustee board.

Restricted funds – these funds can only be used for the particular restricted purposes within the objects of the charity. Restrictions, which are legally binding, arise when specified by the donor or when funds are raised for particular restricted purposes.

The aim and use of each restricted fund is set out in the notes to the financial statements.

Transfers to or from restricted funds are only made where a legal or constructive obligation has arisen requiring a transfer to be made.

1.8 Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid after taking account of any trade discounts due.

1.9 Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1.10 Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

1.11 Financial instruments

The charity only has financial assets and liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

2 Legal Status of the Charity

The charitable company is limited by guarantee and does not have a share capital.

In the event of the company being wound up each member, or any person who has ceased to be a member within one year of the winding up, undertakes to contribute a sum not exceeding £10 if the company is insolvent.
